

Mechanical Permit Information

The Mechanical Code

The State of Michigan, including the City of Portage, is governed by the 2012 State of Michigan Mechanical Code. Provisions for one and two family dwellings are included in the 2015 State of Michigan Residential Code.

Is a mechanical permit required?

Yes. A mechanical permit is required for the erection, installation, enlargement, alteration, repair, removal, conversion or replacement of a mechanical system governed by the mechanical code. Except for replacement of minor parts, mechanical work shall not be started until a permit for such work has been issued.

Mechanical permits are not required for the following:

- Portable gas heating appliances.
- Replacement of any minor part that does not alter approval of equipment or make the equipment unsafe.
- Portable heating appliances.
- Portable ventilation equipment.
- Portable cooling units.
- Portable evaporative cooler.
- Steam, hot or chilled water piping within any heating or cooling equipment regulated by the code.
- Replacement of any part that does not alter its approval or make it unsafe.
- Self-contained portable refrigeration unit that is not more than 1.5 horsepower.

Who can perform mechanical work?

To obtain mechanical permits, an applicant shall be a State of Michigan licensed mechanical contractor; or a homeowner performing mechanical work in a single family home and accompanying outbuildings owned and occupied, or to be occupied, by the person performing the installation.

FAILURE TO COMPLY WILL RESULT IN UNCOVERING THE WORK AND/OR COURT ACTION. PENALTY FOR VIOLATION MAY BE A FINE OF NOT TO EXCEED FIVE HUNDRED DOLLARS (\$500) OR BY IMPRISONMENT FOR NOT MORE THAN NINETY (90) DAYS, OR BOTH, AT THE DISCRETION OF THE COURT.

 EXPIRATION: Permit shall expire and become null and void if the building or work authorized is not commenced within 180 days from the date of issuance, or if the building or work authorized is suspended or abandoned for a period of 180 days.

Section 23a of the State Construction Code Act of 1972, Act No. 230 of Public Acts of 1972, being Section 125.1523a of the Michigan Compiled Laws, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who perform work on a residential building or a residential structure. Violators of Section 23a are subject to civil fines.
